
TRUST DEED

(herein after collectively called the "Trustee of the Trust") of the Other Part.

WHEREAS the Author of the Trust possesses and absolutely owns cash which are valued at Rs. 1,01,000/-(Rupees One Lac and One Thousand only) and is desirous to establish a Public Charitable Trust for the purposes, views and considerations as follows:

The Trust shall be called as "Kapildeo Singh Harinarayan Foundation".

The Registered office of the Trust shall be at "2M/86, Bahadurpur Housing Colony, Bhootnath Road, Patna, Bihar-800026". The registered office may be shifted to such other place as the Trustees may decide time to time.

Main Objects of the Trust shall be:

To establish and maintain an educational institution for providing and imparting education of all kinds including management, technical, scientific, literacy, commercial and other general/specialized disciplines.

Other objects are:

To apply the income and properties of the Trust for fulfillment of its objects and not to pay any portion there of by way of profit or dividend or bonus to Trustees/members.

Without prejudice to the generality of the above objects and for effectively carrying out the same, the trust shall have power to receive, hold and possess any property including securities of any kind and to construct and maintain any building, manage, transferror otherwise dispose of or deal in any property of security and to enter the any contract for or in connection

For the fulfillment of its objects the Trust may enter into agreement with the any Companies, firms, trust with similar objects and/or other institutions for the fulfillment of its objects, the Trust may enter into agreement with Trust/Societies with similar object to take or give name, licences, brand, infrastructures, premises in the larger interest of the students.

To accept the management of any trust and shall have the power to frame rules and bye laws under its constitution.

To assist the government programs in its implementation and to run them with the help of the government.

To accept any gift, grants, donations, contribution or subscription for the promotion of the trust and to issue appeal, applications for money and funds.

To fulfill its objectives, the trust shall procure help from the government, non-government, and other organizations within the country & abroad. Further the Trust may take loan or advance from its member, relative of the members or from Banks/Financial Institutions at reasonable rate of interest for fulfilling its object.

Area of operation shall be the whole India.

As and when required, the Trust may open a Branch office at any place or places as may be decided by the Trustees.

As and when required, the Trust may add/appoint any person as member/Trustee in the larger interest of the Trust. Such addition/appointment would be done only with the consent of absolute majority in the properly conveyed meeting of the Board of Trustees.

Minimum number of trustees shall be two and maximum number of member/trustee shall be twelve subject to approval from Board of Trustees.

AND WHEREAS the trustees have agreed individually and collectively to set as such and has already taken received of the said cash in pursuance of the aforesaid desire of the Author of the trust, who has irrevocably transferred and handed over the same to the trustees for the purposes of the trust as foresaid.

Now therefore the deed of trust declares and witnesseth:

This in pursuance of the promises, the Author of the trust as settler both hereby convey unto and settle upto the trustees all the cash, hereto hold the same upon trust and the trustees do and each of them both hereby admit and acknowledge the transfer thereof to them with power and subject to the use mentioned herein after.

- The name of the trust shall be "Kapildeo Singh Harinarayan Foundation" a Public Charitable trust, with its registered office at "2M/86, Bahadurpur Housing Colony, Bhootnath Road, Patna, Bihar-800026".
- 2. The trust has been established for the purpose and objects lay down above.
- 3. The Author of the trust shall also function as a member of the board of trustees.
- 4. The trustee shall stand possessed of the cash and hereby conveyed and settled upon and shall use and apply in the larger interest of the trust. The profits and the other income derived thereby for the purpose and object of the trust as aforesaid.
- 5. The cash hereby conveyed to the trustees shall form the corpus of the trust property, but the trustees shall have power from time to time to increase or decrease the corpus, according to the best of their judgment.
- 6. The trust shall be governed by a Board of Trustees. In the event of death, incapacity, insolvency, resignation, the remaining trustee/s shall be entitled to nominate any other person as they think fit and proper to act as trustee in place of the trustee so died incapacitated, declared insolvent, resigned or refused react as such.

- 7. The nomination of any person as a trustee shall be either unanimous or by a majority decision and in the event of the trustees being equally divided on the nomination of any person, the decision in the matter of the Managing Trustees shall be final and conclusive.
- 8. The administration of the trust hereby constituted and the entire control, supervision, regulation, management of the trust property and even the application of the entire or a part of the income and the profits thereof as also of all the donations and contributions and subscriptions, if any received by it shall vest in the uncontrolled discretion of the Board of Trustees subject however always to the provisions contained as herein before.
- 9. The Board of trustees may frame rules and regulations for the administration of the trust and for carrying out the purpose and object thereof and the same may be varied, altered, substituted or added to from time to time by a unanimous decision of the Board of Trustee with a view to introduce more effective administration and carrying out the purpose and the object of the trust, such rules may specifically provide the basis or criterion of the selection of the beneficiaries although preference may be given in such section to the people belonging to the scheduled castes or scheduled tribes, women or downtrodden of other cast of the society.
- 10. The Board of Trustees shall have power to accept donations, contributions, grants or subscriptions from others in cash or kind with or without any special conditions attached thereto provided that any such condition does not contravene the provisions of clause 2, hereof. Subject to the same restrictions, the board of constituted trust has declared.
- 11. The Board of Trustees may elect or nominate anyone of them as the Managing Trustee/Secretary for any period of time. The first Managing Trustee/Secretary shall be Mrs. Seema Rani and she shall hold the office and position up to the time of her death, incapacity, insolvency, resignation or refusal to act as such.

12. The first meeting of the Board of Trustees shall be held within three months of the date of the execution of this deed and shall be summoned by Managing Trustee/secretary day giving at least seven days' notice in writing to all the trustees held an such place and time as may be specified

in the notice and in that meeting all relevant matters relating to the trust shall be considered in all possible details and particularly the ways and the manner to give effect to the provisions of the deed of trust to attain the object and purpose of this trust.

13. The Board of Trustees is empowered to open account in the name of the trust, trustees and/or institution run or conducted by the trust with a Bank/s. Further the Bank Account/s will be operated by the Managing Trustee/Secretary and one other member of the Trust under either or survivor mode or jointly as decided by the Board of Trustees. The Bank account to be opened with any scheduled bank will be operated by under the above mode of operation.

14. The trustees may in their uncontrolled discretion deposit for safe custody any documents or securities relating to or forming part of the trust property with the bank/s as aforesaid on payment of such charges therefore, if any as may be agreed upon and found expedient in the interest of the trust.

- 15. The meeting of Board of Trustees may be held at such time, at such place and on such dates as may be agreed upon by the trustees. Such meetings may be summoned by managing trustee or anyone or more of the trustees by giving at least 21 (twenty one) days notice in writing.
- 16. The Accounting year of the Trust shall be the financial year ending on 31st March of every year.
- 17. If the trustees differ with one another in respect of any such matter with reference to which they enjoy discretion the opinion of the majority of the trustees present or voting at the meeting shall prevail and shall be binding on all the trustees, and in the event of the trustees being equally divided the view taken by the Managing Trustee shall prevail in deciding such matter.
- 18. The objects of the Trust shall be such of those that will make it eligible for exemption from Income Tax under the provisions of income Tax Act. 1961 as amended from time to time
- 19. The Board of Trustees may appoint constituted attorneys or agents and to delegate such attorney or agents all or any of the powers vested on
